Summary Report: Laboratory Testing of Active Ingredients of the Thirteen Samples

Introduction: This ICT laboratory was commissioned by Ingredient Facts to assess the active ingredients (Delta and Gamma Tocotrienols) in eleven samples. The purpose of this testing is to verify the accuracy of Delta and Gamma Tocotrienols recommended by Ingredient Facts.

Samples Information: As requested by Ingredient Facts, the ICT laboratory team ordered thirteen products online. Once we received the products, we carefully noted the order number, Date of purchase, and product name, including the brand name, LOT #, and expiration. We also shared pictures of the packaging slip, sealed package, bottles, and label images with the Ingredient Facts team.

Testing Methodology: We utilized a Craft Method of analysis to determine the presence and concentration of active ingredients (Delta and Gamma Tocotrienols) in the samples.

Results and Discussion: Following thorough analysis using the designated methodologies, the laboratory obtained results for each sample. These results were compared against reference standards to assess the concentration of active ingredients.

Conclusion: Based on the laboratory testing conducted, the presence and concentration of active ingredients in thirteen samples have been determined. Out of the thirteen samples tested 6 were not detected or lower than label claim, 3 could not be determined if they meet label claim because they claim other tocotrienols that were not tested, and 4 met or above the label claim.
